# Meeting Summary (May 29<sup>th</sup>)

JD Solomon, Pee Dee River Basin Council Facilitator, called the May 29<sup>th</sup> meeting of the Pee Dee RBC to order at 9:00 AM. The twenty-fourth meeting of the Pee Dee RBC was held in person and virtually via the Zoom virtual meeting platform. Including the Pee Dee RBC members and planning team, there were 32 people present at this RBC meeting.

The meeting began with Buddy Richardson reviewing the agenda items for the meeting. The Pee Dee RBC approved the RBC meeting agenda and approved the minutes and summary documents from the April meeting. A public comment period was held with no comments. An agency public comment period was held with no comments.

The first item on the agenda was an update on the groundwater modeling work underway. Andrea Hughes updated the Pee Dee RBC on the status of the model and noted a slight delay. Even with the delay, model update progress remains on track with past timeline updates.

The next item was discussion of a field trip in June or July. The RBC decided to move ahead with a virtual meeting for June and a July field trip to Sonoco including a brief meeting.

Matt Lindburg, Brown & Caldwell, led discussion on the status of chapters for the Pee Dee River Basin Plan. Chapters 1, 2, 3, and 8 had already received preliminary approval. Chapters 5 and 6 were distributed and Chapter 5's surface water components received preliminary approval from the RBC with the groundwater component to be written after the groundwater model is updated. Chapter 6 will be reviewed by a subcommittee which will provide Matt Lindburg with revisions and comments. Chapter 7 and 9 were informed by strategy prioritization during the meeting and draft chapters will be distributed in the coming months. Chapter 4 is still being written. Chapter 10 will be the last chapter written in the coming months.

JD Solomon and Matt Lindburg facilitated the group in prioritizing surface water and groundwater strategies for Chapter 7 and policy, legislative, regulatory, technical, and process

recommendation strategy prioritization for Chapter 9. The results were collated at the meeting and initial results presented to those in attendance. The results will be updated with absent member responses and presented at a future RBC meeting.

JD Solomon briefly discussed an interbasin transfer supplement recently requested by Charlotte Water which has the potential to impact both the Catawba and Pee Dee river basins. JD Solomon and Buddy Richardson concluded the meeting at 11:55 AM. The next meeting of the Pee Dee RBC will be June 25, 2024 and will be a virtual only meeting.
